

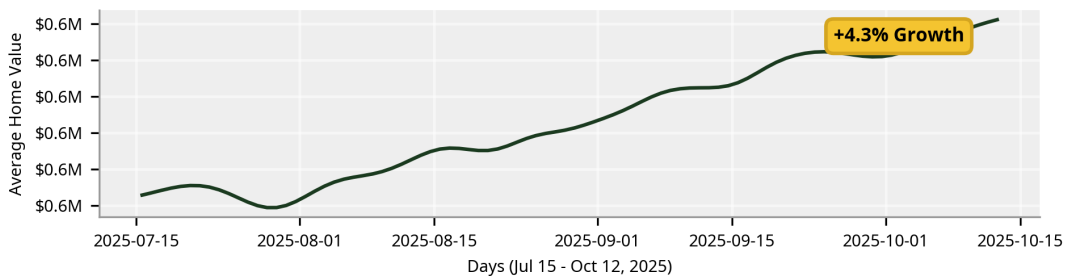
South Park Hill Market Report
