

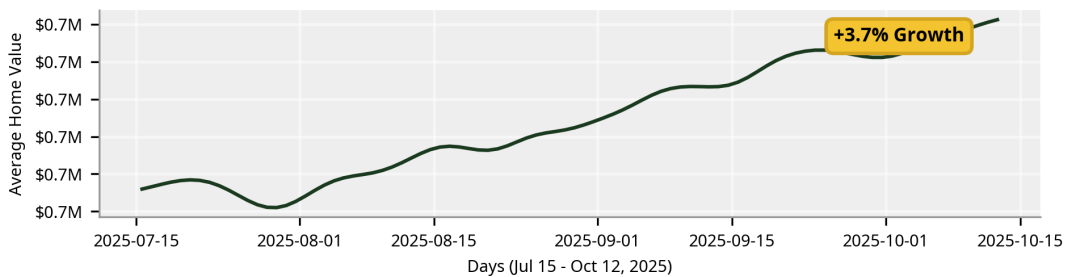
Parker Market Report
