

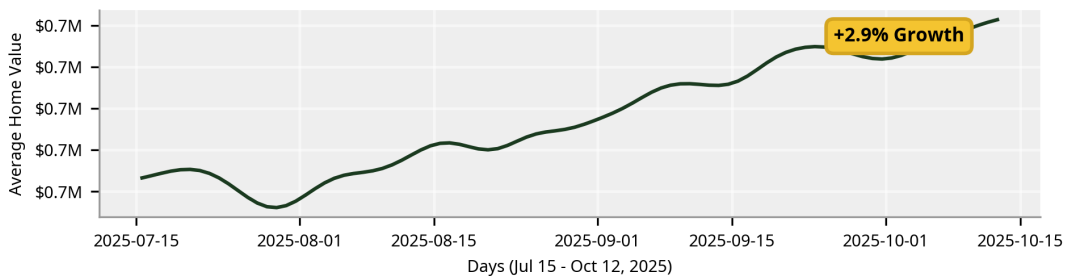
Morrison Market Report
