

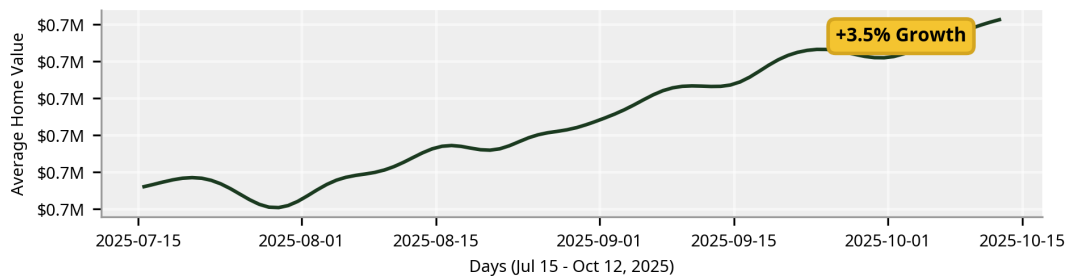
Lone Tree Market Report
