

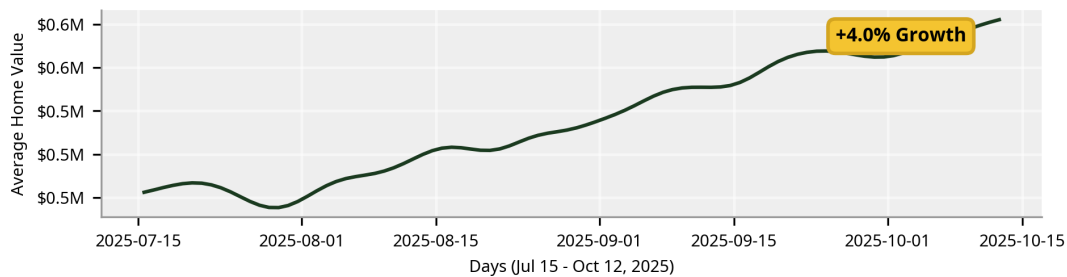
Lakewood Market Report
