

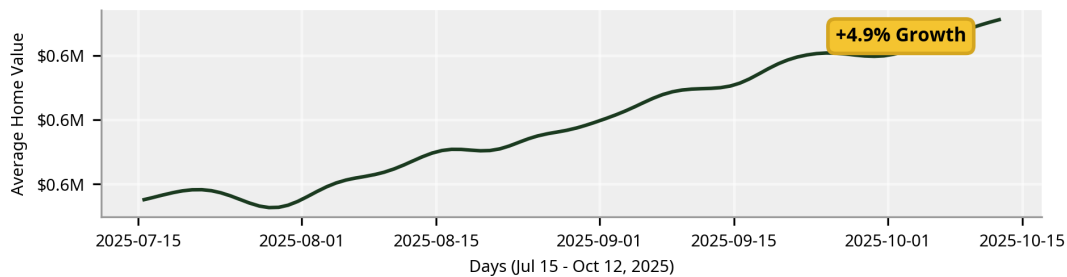
Jefferson Park Market Report
