

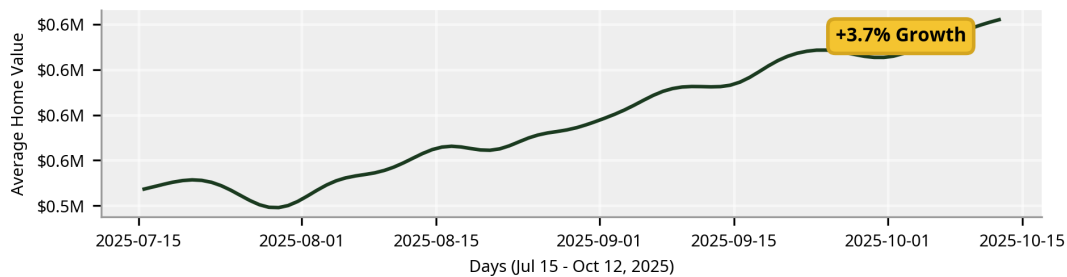
Fort Logan Market Report
